What if my Employer Sponsored plan is an HSA?

Q. What if I have an HSA "Health Savings Account" at work?

Be CAREFUL if your employer plan is a high-

deductible plan with a Health Savings Account. You <u>cannot contribute</u> to an HSA if you have Part A or Part B, but you can continue to withdraw remaining funds from the savings account to pay for qualified expenses.
